This notice is to advise you of the place, day, and hour of the Annual Membership Meeting of Northwest Danish Association ("NWDA"), and other matters pertaining to the meeting.

The Annual Membership Meeting of the Northwest Danish Association will be held on **Saturday, September 30, 2017 at 3:00 pm** in Harmony Hall, Suite 205 at 1833 North 105th Street, Seattle, Washington 98133-8973.

To be eligible to vote at the Annual Membership Meeting, the member's dues for the current fiscal year (July 1, 2017 to June 30, 2018) must be **received** at the office (1833 North 105th Street, Suite 101, Seattle, WA 98133-8973) **on or before September 8, 2017**. Those persons whose dues are not **received on or before September 8, 2017** will not be eligible to vote at the Annual Membership Meeting.

Only members whose dues are **received on or before September 8, 2017** may be nominated for election to the Board of Directors.

"Members" not planning to attend the Annual Membership Meeting may obtain an **"Official Proxy Form"** from the Seattle office of NWDA by leaving a message at (206) 523-3263. The completed and signed **"Official Proxy Form"** must be **returned** to the office so that it is **received** at the Seattle office of NWDA, 1833 North 105th Street, Suite 101, Seattle, WA 98133-8973 **on or before September 8, 2017**. The Official Proxy Form approved by the Board of Directors provides: (1) proxies designating the President as the proxy holder will be voted as directed by the Board of Directors; (2) all other individual members may be designated as a proxy holder for only one other individual member; and (3) if any individual, other than the President, holds more than one proxy, the number of proxies in excess of one proxy will be considered as if the President was the designated proxy holder and voted as directed by the Board of Directors.

“**Organization Members**” shall use the **Organization Proxy Form** to notify the Secretary of NWDA of the name of the Organization’s member who was selected as its qualified representative to vote at the Annual Membership Meeting. The **Organization Proxy Form** shall be used to notify the Secretary and must be **received** at the office of NWDA, 1833 North 105th Street, Suite 101, Seattle, WA 98133-8973 **on or before September 8, 2017.**

Proposals, other than those submitted by the Board of Directors, to be voted on at the Annual Membership Meeting shall be in writing and **received on or before September 8, 2017** at NWDA, 1833 North 105th Street, Suite 101, Seattle, WA 98133-8973.

To be eligible for nomination from the floor at the Annual Membership Meeting, the member proposed to be nominated for the Board of Directors must: (1) have paid membership dues for the current year **on or before September 8, 2017**; (2) be present at the Annual Membership Meeting; and (3) have agreed to serve on the Board of Directors.
